TO ALL WHOM THESE PRESENTS MAY CONCERN: James Perry Harrison and Gloria S.

Harrison

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Twenty-one Thousand Nine Hundred Twenty-nine & 41/100 DOLLARS (\$21,929.41), with interest thereon from maturity at nine per centum per annum, said principal and interest to be repaid:

in one monthly installment of \$208.41 due October 5th, 1979 and 107 consecutive monthly installments of \$203.00 each, the first of said installments being due November 5, 1979 and continuing on the 5th day of each month thereafter until paid in full; said payments including interest at the rate of 18% per annum.

Amount advanced \$10,822.70.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as the northern one-half of Lot No. 111 which is shown on Plot. No. 3 of the Property of Overbrook Land Company and Woodville Investment Company, which plat is recorded in Plat Book F at Page 218 of the RMC Office for Greenville County, also recorded in Plat Book 6-D at Page 86 and known as the property of James Perry Harrison and Gloria S. Harrison.

This is the same property conveyed to the mortgagors by deed T. Pralo Hood recorded January 6, 1977 in Deed Book 1049 at Page 205 and deed recorded June 27, 1977 in Deed Book 1059 at Page 367, RMC Office for Greenville County.
