This Mortgage, made this 16th day of August, 1979, by and between Columbus Lafayette Mullenix & Mullenix hereinafter referred to as Mortgagors, and Dial Finance Company of South Carolina, hereinafter referred to as Mortgagee, witnesseth:

Whereas, Mortgagors are indebted on their promissory note of even date in the sum of \$ 2537.31, payable to Mortgagee and evidencing a loan made to Mortgagors by Mortgagee, which said note is payable in monthly installments, and according to the terms thereof payment in advance may be made in any amount at any time, and default in making any monthly payment shall, at the option of the holder of said note, and without notice or demand, render the entire sum remaining unpaid on said note at once due and payable.

NOW KNOW ALL MEN, that in consideration of said loan and to further secure the payment of said Note and also in consideration of three dollars (\$3) to the Mortgagors in hand well and truly paid by Mortgagee at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, the Mortgagors hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate, situated in the County of Greenville and State of South Carolina, to-wit:

All that piece, parcel of lot of land together with buildings and improvements situate, lying and being on the Southern side of Bramlette Road near the intersection thereof with Gethsemane Drive being shown and designated as a portion of Lots Nos. 15 and 16 on a plat of RUSSELL HEIGHTS, recorded in the RMC Office for Greenville County, S. C. in Plat Book 4F, page 14 and being shown as Lot No. 15 on a Revision of Lots Nos. 15 and 16 of Russell Heights, made by Campbell & Clarkson Surveyors, Inc., dated March 27, 1970 and recorded in the RMC Office for Greenville County, S. C., in Plat Book 4D, page 171, reference to which is hereby craved for the metes and bounds thereof. Title received from Secretary of Housing and Development by deed dated 4/8/75 and recorded 4/23/75 in volume 1017 at page 245 in RMC Office for Greenville County.

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue. Upon default in making any payment of said Note when the payment becomes due, then the entire sum remaining unpaid on said Note shall be due and payable by the exercise of the option of acceleration above described, and this Mortgage may be foreclosed as provided by law for the purpose of satisfying and paying the entire indebtedness secured hereby.

The Mortgagors covenant that they exclusively possess and own said property free and clear of all encumbrances except as otherwise noted, and will warrant and defend the same against all persons except the Mortgagee. Any failure of the Mortgagee to enforce any of its rights or remedies hereunder shall not be a waiver of its rights to do so thereafter. Whenever the context so requires, plural words shall be construed in the singular.
