Greenville County, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Charter Mortgage Company

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the western side of Cadillac Court and being known and designated as Lot No. 20 as shown on plat of Section Two, COACHMAN ESTATES, made by Campbell & Clarkson, Surveyors, dated August 3, 1972, and recorded in the RMC Office for Greenville County in Plat Book 4-R at Page 29 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
