MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, <sup>R.S.</sup> RANDALL G. SHEPERD and <sup>H</sup> <sup>D.S.</sup> DEBRA G. SHEPERD

(hereinafter referred to as Mortgagor) is well and truly indebted unto

ASSOCIATES FINANCIAL SERVICES COMPANY OF SOUTH CAROLINA, INC.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

FOURTEEN THOUSAND THREE HUNDRED SIXTY-FOUR Dollars (\$ 14,364. ) due and payable  
in Eighty-four (84) equal, consecutive monthly installments of \$171.00,  
commencing January 19, 1980, and continuing thereafter until paid in full

as stated in Note of even date  
with interest thereon from date / at the rate of per centum per annum, to be paid:

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, being shown and designated as Lot 55 on a Plat of Section One, SUNNY SLOPES Subdivision, recorded in the RMC Office for Greenville County in Plat Book 4-R, at Page 3, and having, according to said Plat, the following courses and distances:

BEGINNING at a point on the edge of Barclay Drive, joint front corner of Lots 54 and 55, and running thence with the common line of said Lots, S 36-42 E, 150 feet to a point; thence S 63-18 W, 80 feet to a point; thence N 36-42 W, 150 feet to a point on the edge of Barclay Drive; thence running with said Drive, N 53-18 E, 80 feet to a point on said Drive, the point of beginning.

This is the same property conveyed to the Mortgagors herein by deed of Brown Enterprises of S. C., Inc., recorded May 5, 1975, in Deed Book 1017, at Page 769.
