- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assassments, repairs or other purposes pursuant to the covenants herein. Whenever used, the singular shall included the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
