"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, as follows, to-wit:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the southern side of Gary Avenue, Greenville, S. C., being known and designated as Lot No. 22 on plat entitled "May 1, Cunningham Acres," prepared by C. O. Riddle, dated March, 1966, which plat is recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book BBB, at Page 118, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Gary Avenue, said pin being the joint front corner of Lots No. 21 and 22; running thence with the common line of said Lot No. 21 S. 5-20 W. 165 feet to an iron pin at the joint rear line of Lot No. 29; thence with the rear line of Lots No. 29 and 28 N. 84-40 W. 110 feet to an iron pin at the joint rear corner of Lots No. 22 and 23; thence with the line of Lot No. 23 N. 5-20 E. 165 feet to an iron pin on the southern side of Gary Avenue; thence with the southern side of Gary Avenue S. 84-40 E. 110 feet to the point of BEGINNING.
