MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Judy C. Poole,

(hereinafter referred to as Mortgagor) is well and truly indebted unto Mollie Sarkis,

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the Cateechee Road in what is now known as Cherokee Park, and being known and designated as Lot No. 73, as shown on plat of record in the RMC Office for Greenville County in Plat Book C-96, reference to which is hereby craved for a metes and bounds description thereof.

This being the same property conveyed to the Mortgagor herein by Deed of Mollie Sarkis, of even date and to be recorded herewith in the RMC Office for Greenville County.
