All that lot of land situate on the West side of Brush Street, and on the South side of Ella Street (formely known as Lone Hall Street), in the City of Greenville, in Greenville County, South Carolina, being shown as Lots No. 5 and 6, on Map No, 2 of Nickle Town Heights, recorded in the RMC Office for Greenville County, S.C., in Plat Book "M", at Page 5, and having, according to said plat, the following metes and bounds, to-wit:
