ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in the City of Greer, and on the North side of Mayfield St., and bounded by lands of Littlefield on the West, Annie P. Gash on the North, D.A. Lister and others on the East, and Mayfield Street on the South, having a frontage on the said Mayfield St. of 79 feet more or less and a depth of 168 ft. more or less, by a width of 60 ft. more or less and by a depth on the East side of 211 ft. more or less and being a portion of the lot conveyed to J.M. Gash by J.D. Mayfield as shown by deed recorded in the Office of R.M.C. in and for Greenville County, save and except, and it is so understood and agreed, that a right of way of ten feet wide (10') and along the entire length of the western side of this lot adjoining Littlefield land, is to be and remain open for the benefit of the lot north of the above described lot as a means of ingress and egress to Mayfield Street.
