"ALL that certain piece, parcel or lot of land, with all improvements thereon, or bereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Tract 4 on plat of Property of T. Walter Brashier, recorded in the RMC Office for Greenville County in Plat Book 7-A at page 46 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northeastern side of S. C. Highway 414 in the center of said highway at the joint front corner of Tracts 4 and 5, and running thence along the line of Tracts 4 and 5, N. 31-46 W. 775.2 feet to an iron pin at the joint rear corner of Tracts 4 and 5 in the line of property of Youngblood; thence along the line of Youngblood property, S. 76-24 W. 100 feet to an iron pin, joint rear corner of Tracts 4 and 3; thence along the line of said tracts S. 16-55 E. 756.2 feet to an iron pin in the center of S.
