possession to let the said premises, and receive all the rents, issues and profits thereof, which are overdue, doe or 508 to become due, and to apply the same, after payment of all necessary charges and expenses on account of the indebtedness hereby secured; and the said rents and profits are hereby assigned to the mortgagee as security for the payment of such indebtedness.
