WHEREAS, Borrower is indebted to Lender in the principal sum of Forty Two Thousand
Three Hundred and 00/100 ------Dollars, which indebtedness is evidenced by Borrower's
note dated September 10, 1980(herein "Note"), providing for monthly installments of principal
and interest, with the balance of the indebtedness, if not sooner paid, due and payable on
October 1, 2010

ALL that certain piece, parcel or lot of land with all buildings and improvements thereon situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 5 according to a plat of White Oak Hills, Section One, recorded in the Greenville County R.M.C. Office in Plat Book 7-C at Page 33, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Green Fern Drive at the joint front corner of Lots 4 and 5 and running along the eastern side of said Drive, N. 19-10 W. 63.7 feet to an iron pin; thence continuing along the eastern side of said Drive, N. 11-15 W. 45 feet to an iron pin; thence along the common line of Lots 5 and 6, N. 74-39 E. 170.95 feet to an iron pin; thence S. 20-55 E. 30.0 feet to an iron pin; thence S. 33-45 E. 20 feet to an iron pin; thence along the common line of Lots 3, 4 and 5, S. 56-15 W. 188.8 feet to an iron pin on the eastern side of Green Fern Drive, the point of beginning.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
