ALL that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, containing 12.5 acres, as is more fully shown on a plat entitled "Survey for Richard Watson", prepared by Carolina Surveying Company, dated June 27, 1980, revised August 19, 1980, revised August 27, 1980, revised September 3, 1980, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at a concrete right of way monument on the northeastern edge of the right of way of I-385, at the corner of property of Pate, and running thence along the northeastern edge of said right of way, N. 46-53 W. 1,087.5 feet to a concrete right of way monument at the corner of tract containing 10.92 acres, and running thence along the joint line of said tract, N. 69-15 E. 859.1 feet to a point on the southern side of the right of way of a proposed road; running thence along the southern side of said proposed road, S. 57-55 E. 78.5 feet to a point in the line of property of Pate; and running thence along the line of said property, S. 6-14 E. 977.2 feet to an iron pin at the corner of Pate; running thence with the line of said property, S. 79-15 W. 185.4 feet to the point of beginning.

BEGINNING at a stake on the southern side of Pelham Road, at its intersection with Haywood Road and running thence along the southern side of Pelham Road, N. 84-07 E. 1,391.7 feet to a stake; running thence N. 87-55 E. 99.5 feet to a stake; running thence S. 85-33 E. 100.6 feet to a stake; running thence S. 79-11 E. 100.0 feet to a stake; running thence S. 72-58 E. 99.6 feet to a stake; running thence S. 68-57 E. 338.4 feet to a stake at the intersection of Pelham Road and a proposed road; running thence with the curvature of said intersection, the chord of which is S. 25-48 E. 43.8 feet to a stake; running thence with the western side of said proposed road, S. 17-20 W. 220.6 feet to a stake at the corner of a tract containing 25.2 acres; running thence with the line of said tract, the following courses and distances to-wit: N. 68-57 W. 387.9 feet to a stake; N. 82-42 W. 278.88 feet to a stake; S. 84-07 W. 1,433.1 feet to a stake on the eastern side of Haywood Road; running thence with the eastern side of Haywood Road, N. 8-06 W. 200.8 feet to a stake at the intersection of Haywood Road and Pelham Road; running thence with the curvature of said intersection, the chord of which is N. 40-06 E. 71.0 feet to the point of beginning.

BEGINNING at a stake on the eastern side of Haywood Road at the corner of property of Mobil Oil Corporation and running thence with the eastern side of Haywood Road, N. 4-21 W. 101.65 feet to a stake; thence continuing with the eastern side of Haywood Road, N. 7-02 W. 87.0 feet to a stake; thence continuing with the eastern side of Haywood Road, N. 8-06 W. 12.5 feet to a stake at the intersection of Haywood Road and a proposed road; running thence with the curvature of said intersection, the chord of which is N. 40-57 E. 32.8 feet to a stake on the southern side of said proposed road; thence with the southern side of said proposed road, S. 89-59 E. 314.78 feet to a stake at the corner of a tract containing 0.257 acres; thence with the line of said property, S. 0-01 W. 223.9 feet to a stake in the line of a tract containing 3.50 acres; running thence with the line of said property, N. 89-59 W. 119.88 feet to a stake at the corner of property of Mobil Oil Corporation; running thence with the line of said property, N. 89-59 W. 196.3 feet to the point of beginning.
