MORTGAGE

THIS MORTGAGE is made this 10th day of October, 1980, between the Mortgagor, B. & B. BUILDERS, INC. (herein "Borrower"), and the Mortgagee, POINSETT FEDERAL SAVINGS AND LOAN ASSOCIATION of Travelers Rest, a corporation organized and existing under the laws of South Carolina, whose address is 203 State Park Road, Travelers Rest, S. C. 29690 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Thirty-One Thousand Five Hundred and No/100ths Dollars, which indebtedness is evidenced by Borrower's note dated October 10, 1980 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on March 1, 2010.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land located in the County of Greenville, State of South Carolina and being known and designated as Lot No. 86 on a plat of Sunny Acres Subdivision, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book BB at Pages 168 and 169, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern edge of Paris View Avenue at the joint front corner of Lots Nos. 86 and 87 and running thence with the line of Lot No. 87, N. 29-30 W. 148.1 feet to a point; thence N. 57-55 E. 75 feet to a point in the joint rear corner of Lots Nos. 85 and 86; thence with the line of Lot No. 85, S. 29-30 E. 149 feet to a point on the northern edge of Paris View Avenue; thence with Paris View Avenue, S. 59-50 W. 75 feet to an iron pin, the point of beginning.

Being a portion of the same property conveyed to the mortgagor herein by deed of Poinsett Service Corporation, said deed being recorded in the R.M.C. Office for Greenville County in Deed Book 1079 at Page 735.
