MORTGAGE (Construction)

THIS MORTGAGE is made this 13th day of October,
19 80, between the Mortgagor, PREFERRED HOMES, INC.

, (herein "Borrower"), and the Mortgagee, South Carolina
Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of
America, whose address is 1500 Hampton Street, Columbia, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Sixty-Six Thousand Eight
Hundred and No/100 (\$66,800.00)----- Dollars or so much thereof as may be advanced, which
indebtedness is evidenced by Borrower's note dated October 13, 1980, (herein "Note"),
providing for monthly installments of interest, with the principal indebtedness, if not sooner paid, due and payable
on April 1, 1982.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the
payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this
Mortgage and the performance of the covenants and agreements of Borrower herein contained, (b) the performance
of the covenants and agreements of Borrower contained in a Construction Loan Agreement between Lender and Bor-
rower dated October 13, 19 80, (herein "Loan Agreement") as provided in paragraph 20
hereof, and (c) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to
paragraph 17 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and
Lender's successors and assigns the following described property located in the County of Greenville
State of South Carolina:

ALL that piece, parcel or lot of land situate, lying and being on the North-
western side of Kindlin Way, near the City of Greenville, in the County of
Greenville, State of South Carolina, and known and designated as Lot No. 5
on a plat of the Subdivision known as Fox Ridge at Pebble Creek, Phase I,
plat of which is recorded in the R.M.C. Office for Greenville County in Plat
Book 7-C at Page 67, and, according to said plat, has the following metes and
bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Kindlin Way, at the joint
front corner of Lots Nos. 5 and 6, and running thence with the joint line of
said Lots N. 52-06 W. 163.98 feet to an iron pin in the line of Duke Power
right-of-way; running thence N. 53-01 E. 101.52 feet to an iron pin at the
joint rear corner of Lots Nos. 4 and 5; running thence with the joint line of
said Lots S. 37-00 E. 146.21 feet to an iron pin on the Northwestern side of
Kindlin Way; running thence with the Northwestern side of said Way S. 41-23 W.
60 feet to an iron pin, point of beginning.

TO HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the im-
provements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties,
mineral, oil and gas rights and profits, water, water rights, and water stock, all fixtures now or hereafter attached to
the property, and all appliances, building materials, and other moveables placed in or upon the property if the same
