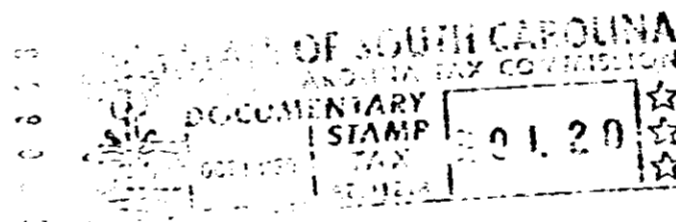
with interest thereon from date at the rate of -12- per centum per annum, to be paid: in said monthly installments
