"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the western side of Lawton Avenue and having according to plat of Property of H. W. Webb and C. C. Carter, recorded in Plat Book I at Page 31, RMC Office for Greenville County, SC, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Lawton Avenue, which pin is 141.3 feet south of the southwestern corner of the intersection of Doughit Street and Lawton Avenue, and running thence N. 71-30 W. 173 feet to an iron pin; thence S. 17-30 W., 50 feet to an iron pin; thence S. 71-30 E., 173 feet to an iron pin on Lawton Avenue; thence with the western side of Lawton Avenue N. 17-30 E. 50 feet to the point of beginning.
