All that certain parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, on the West side of Durham Road, approximately 1500 feet Southeast of its intersection with Berrys Mill Road, being shown as containing 1.25 acres on a plat of property prepared for Robert E. Brooks by Lindsey & Assoc., dated June 18, 1980, recorded in Plat Book 8-F page 62 and having such metes and bounds as is thereby shown. According to said plat, said property joins grantees' existing lot on the West a distance of 199.9 feet, with a depth of 330.2 feet on the South, a depth of 213.9 feet on the North, and with a rear width of 230.4 feet.
