BEGINNING at an iron pin on the Northwestern side of Church Street at its intersection with Guess Street and running thence with the Northwestern side of Church Street the following courses and distances: S. 28-52 W. 97.94 feet to an iron pin, thence S. 33-21 E. 81.91 feet to an iron pin, thence S. 50-58 E. 2.0 feet to an iron pin, thence S. 39-02 W. 256.7 feet to an iron pin, thence N. 50-58 W. 17.0 feet to an iron pin, thence S. 39-05 W. 381.0 feet to an iron pin at its intersection with Ligon Street; thence with the Eastern side of Ligon Street the following courses and distances: N. 52-37 E. 165.2 feet to an iron pin, thence N. 45-57 W. 59.93 feet to an iron pin, thence N. 43-02 W. 116.75 feet to an iron pin; thence turning and running N. 62-01 E. 134.9 feet to an iron pin; thence N. 31-30 W. 91.38 feet to an iron pin; thence N. 30-56 W. 63.7 feet to an iron pin; thence N. 37-47 W. 46.5 feet to an iron pin; thence N. 55-37 W. 106.15 feet to an iron pin; thence N. 77-12 W. 98.8 feet to an iron pin; thence S. 87-36 W. 78.18 feet to an iron pin; thence S. 82-55 W. 67.81 feet to an iron pin; thence S. 82-55 W. 76.69 feet to an iron pin on the Southeastern side of Seth Street; thence with the Southeastern side of Seth Street N. 23-38 E. 156.75 feet to an iron pin at its intersection with Lake Circle Street; thence with the Southern side of Lake Circle Street the following courses and distances: N. 59-15 E. 112.0 feet to an iron pin, thence N. 56-10 E. 64.67 feet to an iron pin, thence N. 59-02 E. 91.0 feet to an iron pin, thence N. 67-33 E. 31.4 feet to an iron pin, thence N. 45-15 E. 36.0 feet to an iron pin, thence N. 43-42 E. 60.0 feet to an iron pin, thence N. 22-50 E. 67.75 feet to an iron pin, thence N. 3-57 E. 134.45 feet to an iron pin at its intersection with Seth Street; thence with the Southeastern side of Seth Street N. 81-39 E. 277.59 feet to an iron pin; thence continuing with the Southeastern side of Seth Street N. 56-17 E. 147.35 feet to an iron pin on the Western side of Guess Street; thence with the Western side of Guess Street S. 17-36 W. 492.69 feet to the point of beginning.
