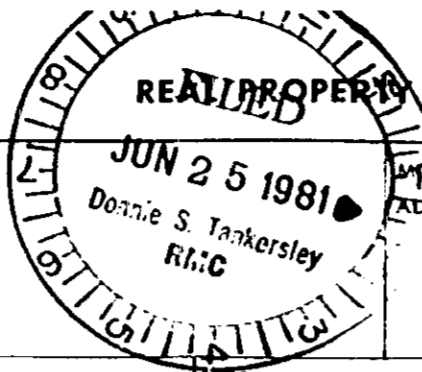

To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that certain lot of land, with all improvements thereon, in the City of Greer, Chich Springs Township, and in said State and County and being more particularly described as Lot No. 40 on a plat entitled "Subdivision for McCall Mfg., Co., Greer, S.C.," prepared by Pickell & Pickell, Greenville, S.C., May, 1949, and recorded in the R.M.C. Office for this County, in Plat Book "S", at page 76, said lot also being known as No. 103 Franklin Street (now Delano Avenue) and fronts thereon 96 feet.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.

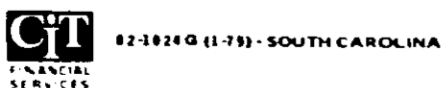
