"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville as shown on a plat entitled "Property of Surendra Jain - Mohammed Nasim" dated June 19, 1972, prepared by Jones Engineering Services and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 6-S at page 11, and being more particularly described as that triangular portion shown on said Plat and remaining after the sale of the 4.75 acre tract and the 2.0 acre tract and having the dimensions of 185'6" X 411.6' X 35.3' X 324.2' as shown on said plat.
