(2) Owner(s) agree to pay said tap fee in installments as follows: (a) \$\frac{100.00}{paid}\$ down at this time; (b) the balance of \$\frac{300.00}{300.00}\$ to be paid in equal annual installments of \$\frac{100.00}{100.00}\$ each, plus interest on the unpaid balance at the rate of eight (8%) percent per annum, commencing one year from this date. All accrued interest shall be due and payable annually, together with the annual principal payment.
