WITNESSETH, that to secure the payment of an indebtedness in the principal amount of Nine Thousand Three Hundred & Dollars (\$ 9,350.00 ), with interest thereon, which shall be payable in accordance with a certain note, bond or other obligation (which note, bond or obligation is hereinafter called "Note"), bearing even date herewith, a true and correct copy of which, exclusive of the signature of the Mortgagor, marked "Schedule A", is annexed hereto and made a part hereof, and all other indebtedness which the Mortgagor is obligated to pay to the Mortgagee pursuant to the provisions of the Note and this Mortgage, the within written Mortgage is given.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the said Mortgagee, its successors and assigns, the following described real assigns to wit: scribed real estate, to with

ALL that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, shown as Lot No. 26 on a plat of Oakland Heights Subdivision made by F. H. and J. G. Cunningham, and revised by R. E. Dalton, and recorded in the RMC Office for Greenville County in Plat Book C at page 147, and according to said plat having the following metes and bounds to-wit:

BEGINNING at an iron pin on Camperdown Way, 60 feet from the intersection of Camperdown Way and Oakland Avenue, and running thence with Camperdown S 62-19 E 60 feet to an iron pin at the corner of Lot No. 27; thence along the line of Lot No. 27 N 34-50 E 150 feet to an iron pin; thence N 62-19 W 60 feet to an iron pin; thence S 34-50 W 150 feet to the point of beginning.

This property is known and designated as Block Book No. 68-3-9.

DERIVATION: Lot 26 being the same property devised to Homer Springfield by will of Mary L. Springfield, who died testate on December 19, 1957 (see Probate File 677-26). On October 23, 1959 Homer Springfield in an erroneous deed conveyed Lot No. 27 which he did not own, to George R. Fowler; said deed being recorded on March 31, 1960 in Deed Book 647 at page 218. Subsequently Homer Springfield died testate on June 10, 1966, leaving as his only heir his wife Elise R. Springfield. A corrective deed was done on April 17, 1980, in which Elise R. Springfield conveyed Lot No. 26 to George R. Fowler; said deed being recorded in Deed Book 1124 at page 490, on April 23, 1980.
