MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Calvin Dean McDaniel and Ruth N. McDaniel

(hereinafter referred to as Mortgagor) is well and truly indebted unto The City of Greenville a municipal corporation, Post Office Box 2207, Greenville, South Carolina 29602

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand Five Hundred Twenty-Five and No/100----- Dollars (\$ 7,525.00 ) due and payable

with interest thereon from 15th day of \_\_\_\_\_ month after work completed at the rate of 3% per centum per annum, to be paid: 72.66 per month

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the southeastern side of Bleckley Avenue, and known and designated as Lot No. 8, Block E of a subdivision known as Fair Heights, a plat of which is recorded in the RMC Office for Greenville County in Plat Book F at page 257; and having according to said plat the following metes and bounds to-wit:

BEGINNING at a point on the northern side of Bleckley Avenue, and running thence with said Avenue N 31-20E 50 feet to the joint front corner of Lots 7 and 8; thence with the joint line of Lots 7 and 8 N 58-40 W 150 feet to a point; thence running S 31-20 W 50 feet to a point being the joint rear corner of Lots 8 and 9; running thence with the joint line of Lots 8 and 9 S 58-40 E 150 feet to the point of beginning.

This property is known and designated as Block Book No. 265-8-9.
