TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, DOROTHY H. SUBER AND HOSEA L. SUBER

(hereinafter referred to as Mortgagor) is well and truly indebted unto GREENVILLE COUNTY REDEVELOPMENT AUTHORITY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven thousand one hundred seventy and no/100----- Dollars (\$ 7,170.00) due and payable in 120 consecutive monthly installments of Sixty-nine and 26/100 (69.26) Dollars each, due and payable on the fifteenth day of each month, commencing May 15, 1982,

with interest thereon from said date at the rate of three (3%) per centum per annum, to be paid: monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, better known and described as Lot No. 22, Section F of the property known as Washington Heights, surveyed by N. O. McDowell, Jr. and Julian P. Moore, in December, 1944; recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book H, Page 107, to which plat and the record thereof reference is hereby made.
