All that piece, parcel or lot of land situate, lying and being on the Southern side of Greybridge Drive, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 2 as shown on a plat entitled "Trollingwood, Section I", prepared by Enwright Associates, dated September 30, 1971, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R at Page 13 and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the Southern side of Greybridge Drive at the joint front corner of Lots Nos. 1 and 2 and thence running the line of Lot No. 1 S. 14-53 E. 248.3 feet to an iron pin at the normal pool line of a lake known as Lake Trollingwood; thence with the normal pool line of said lake, N. 87-52 W. 100 feet to an iron pin; thence continuing with the normal pool line of said lake, N. 87-57 W. 94.9 feet to an iron pin at the joint rear corner of Lots Nos. 2 and 3; thence with the line of Lot No. 3 N.2-05 W. 200.6 feet to an iron pin on the Southern side of Greybridge Drive; thence with the Southern side of Greybridge Drive; N. 76-31 E. 142 feet to the point of beginning.
