"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, bing and being in the State of South Carolina, County of Greenville, State of South Carolina, on the south side of Woodfin Avenue (formerly McKay Street) and being known and designated as a portion of Lot No. 3 on plat of Property of James Birnie recorded in the R.M.C. Office for Greenville County in Plat Book "C", at Page 200 and having, according to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin on the southern side of Woodfin Avenue at the joint front corner of Lots Nos. 2 and 3 and running thence along the joint line of said lots S. 53-15 E. 110.75 feet, to an iron pin; thence S. 87-35 W. 50 feet to an iron pin; thence along the joint line of Lots Nos. 3 and 4 N. 3-15 W. 110.58 feet, to an iron pin on the south side of Woodfin Avenue; thence along said Avenue N. 86-15 E. 50 feet to the point of beginning.

THIS property is known and designated as Block Book No. 95-9-6.

BEING the same property conveyed to the mortgagor, then known as Rozella A. Rhodes by deed of Bessie B. Miller, recorded in the RMC Office for Greenville County in Deed Book 821 page 436, on June 12, 1967.

THIS mortgage is junior and subordinate to a mortgage executed by Rozella A. Rhodes to Cameron-Brown Company; recorded in REM Book 1060 at page 233, on June 12, 1967. Said mortgage was assigned to Federal National Mortgage Association, as recorded in REM Book 1062 page 656, on July 10, 1967.

FUTURE ADVANCES: As additional consideration, pursuant to Section 29-3-50 of the 1976 Code of Laws of South Carolina, this mortgage is given to cover, in addition to all existing indebtedness of Mortgagor to Mortgagee (including but not limited to the above described advances) evidenced by promissory notes, and all renewal and extensions thereof, all future advances that may be made to Mortgagor by Mortgagee, to be evidenced by promissory notes, and all renewal and extensions thereof, the maximum principle amount of all existing indebtedness and future advances outstanding at any one time not to exceed \$12,500 plus interest thereon, attorney's fees and court costs as provided herein.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
