"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of Sevier Street near Augusta Road and known as Lot No. 1 on a plat made by R. E. Dalton and recorded in the Office of the RMC for Greenville County in Plat Book G at Page 246, and having metes and bounds as shown thereon.

This being the same property acquired by the Mortgagor, B. Robert Coker, Jr. by deed of Wyatt A. Seybt, Jr. dated October 14, 1977 and recorded in the RMC Office for Greenville County on October 24, 1977 in Deed Book 1067 at Page 240 and said B. Robert Coker, Jr. subsequently conveyed a one-half (1/2) interest in said property to David C. Waldrep, II by deed dated August 30, 1979 and recorded in the RMC Office for Greenville County in Deed Book 1112 at Page 118 on September 26, 1979.
