To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville ~~and State of South Carolina~~

All that lot of land in Greenville County, State of South Carolina, lying and on the southeast side of East 7th Street in Woodside Village near the City of Greenville, being shown as Lot No. 52, Section C, on plat of Woodside Mills Subdivision prepared by Pickell & Pickell dated January 14, 1950, recorded in Plat Book "M", at page 111-117, and having, according to said plat, such metes and bounds as shown thereon.

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

You may pay any such tax, lien, assessment, obligation, encumbrance or other charge or purchase such insurance in your own name, if I fail to do so. I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
