Saving Clause.

Should any term, provision, covenant or portion thereof or condition of this Mortgage be held to be 122 or invalid, the same shall not affect any other term, provision, covenant or condition of this Mortgage, but the remainder hereof shall be effective as though such term, provision, covenant or condition had not been contained herein.
