To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that piece, parcel or lot of land containing 11,000 sq ft. more or less, situated, lying and being in Greenville Township, in the County and State aforesaid, near the southern limit of the City of Greenville, and having the following metes and bounds; wit:

Beginning at a stake 3 X on east side of Church Street (now Mission Street) and running thence with said street S 36-1/2 E. 55 feet to a stake; thence N 53-1/2 E 200 feet to a stake 3X; thence N 36-1/2 W 55 feet to a stake 3X; thence S 53-1/2 W 200 feet to the beginning corner. I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
