MORTGAGE

THIS MORTGAGE is made this 7th day of October, 1982, between the Mortgagor, Robert S. Steele and Barbara P. Steele (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings & Loan Association, a corporation organized and existing under the laws of United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina, (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Sixty-five thousand and no/100 (65,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated November 1, 2012 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on Greenville.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that certain, piece, parcel or lot of land with the buildings and improvements, thereon, lying and being at the southerly intersection of Hunting Hill Cricle and Cherrywood Trail, near the City of Greenville, South Carolina, being known and designated as Lot 537 in plat entitled Map Four, Section Two, Sugar Creek, as recorded in the RMC Office for Greenville County, S.C. in Plat Book 8-P at Page 62, said plat being referred to for a more complete description thereof.
