The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hireafter, at the opins n of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the constitutes bettern. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgagor by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof.
