WHEREAS, I, we the said Ronald Skipper Stephens hereinafter
called Mortgagor, in and by my, our certain note or obligation bearing even date herewith, stand indebted
firmly held and bound unto the Citizens and Southern National Bank of South Carolina. Greenville
S. C., hereinafter called Mortgagee, the sum of \$23,113.28 plus interest as stated in the note of
obligation, being due and payable in $\frac{120}{}$ equal monthly installments commencing on the $\frac{15}{}$
day ofJanuary 19_83 and on the same date of each successive month thereafter
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may
be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or fo
any other purposes:
NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of an other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgage at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold an released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, and the improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in the Brushy Creek Baptist Church Community, lying on the Southern side of the Lower Brushy Creek Road, being bounded on the North by the said Lower Brushy Creek Road, on the West and Southern side by the property of Ronald and Betty Wade Stephens, and others, and on the East side by the property of Ross L. Wade.

BEGINNING on a point in the center of the Lower Brushy Creek Road, said point being an extension of the Northern line of Ronald and Betty Wade Stephens lot, and runs thence with the said Stephens line, S. 64-00 E. 282 feet to a stake or iron pin on the Stephens corner; thence with another line of the Stephens property, extended, N. 27-55 E. 9 feet to an old iron pin in an old abandoned road; thence with the said abandoned road, S. 82-45 E. 75 feet to an iron pin; thence a new line, N. 18-45 W. 207 feet to a nail and cap in the center of the Lower Brushy Creek Road (iron pin back on line at 30 feet); thence with the center of the said road, S. 75-00 W. 275 feet to the beginning point, containing 0.75 acre, more or less.

This being the same property conveyed to mortgagor herein by deed of Richard L. Wade dated August 12, 1981 and recorded August 12, 1981 in Deed Book 1153 at page 440 in the R.M.C. Office for Greenville County.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
- (2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the halance owing on the Mortgagee debt whether due or not
- (3) That it will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction lean, that it will continue construction until completion without interruption, and should it fail to do so, the Mortgagee may, at its option, enter upon said premises make whatever repairs necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of some construction to the mortgage debt.
