note in writing, of even date with these presents, are well and truly indebted to Southern Bank and Trust

in the full and just sum of Five Thousand One Hundred Eleven and 08/100

(\$5,111.08) Dollars to be paid in Thirty-Six (36) equal installments in the sum of One Hundred Eighty and 88/100 (\$180.88) Dollars each, beginning March 1, 1983, and a like installment being due and payable on the 1st day of each and every calendar month thereafter until paid in full.

with interest thereon from date

at the rate of 16.00 per cent, <sup>a.p.r.</sup> ~~per annum~~ to be computed and paid monthly
