Whereas, I the said David Ray Burton, Sr.
in and by my certain promissory
note in writing, of even date with
these presents, am well and truly indebted to Southern Bank and Trust
Company of Williamston, South Carolina
in the full and just sum of Three Thousand Twenty and 68/100 (\$3,020.68)
be paid in Thirty-Six (36) equal installments in the sum of One Hundred Six and 76/100 (\$106.76) Dollars each, beginning March 15, 1983, and a like installment being due and payable on the 15th day of each and every calendar month thereafter until paid in full.
, with interest thereon fromdate
at the rate of 16.00per cent, pexikara to be computed and paid monthly
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing
