This document, which is defention in the state of the 19 83 called the "Mortgage." Mendel I. Hawkins will sometimes be called "Borrower" and sometimes simply "I."
Borrower's address is: Rt. 1, Box 477-B, Moore, S.C. 29369 (C) "Lender." COMMUNITY BANK will be called "Lender." Lender is a corporation which was formed and which exists under the law of the State of South Carolina. Lender's address is: POST OFFICE BOX 6807, GREENVILLE, SOUTH CAROLINA 29606. (D) "Note." Any promissory note or notes signed by Borrower which contain a recital therein stating in effect that : "This Note is secured by a Master Real Estate Mortgage dated July 14, 1983 " will be called the "Note". It is the intention of Borrower to facilitate future financing through Lender by executing this Master Mortgage to secure future advances which shall be evidenced by Notes executed at the time of such advances; the terms of such future advances shall be negotiated at the time of such advances, but the total principal balance of all obligations or advances secured hereby shall not exceed the sum of One Hundred Eighty-Five Thousand and no/100-----(\$ 185,000.00). (E) "Property." The property that is described below in the section titled "Description Of The Property," will be called the Property. DESCRIPTION OF THE PROPERTY I give Lender rights in the Property described in (A) through (I) below: (A) The property which is located at (Street) (State and Zip Code) (City) County in the State of South Carolina. It has the following legal description. This property is in Greenville See attached Schedule A STAME 14 T18.1 Lot 119 & 120 ... Sheet 537.5 Rinck (B) All buildings and other improvements that are located on the property described in Paragraph (A) of this section; (C) All rights in other property that I have as owner of the property described in Paragraph (A) of this section. These rights are known as "easements, rights and appurtenances attached to the property"; (D) All rents or royalties from the property described in Paragraph (A) of this section; (E) All mineral, oil and gas rights and profits, water, water rights and water stock that are part of the property described in Paragraph (A) of this section; (F) All rights that I have in the land which lies in the streets or roads in front of, adjacent, or next to, the property described in Paragraph (A) of this section; (G) All fixtures that are now or in the future will be on the property described in Paragraphs (A) and (B) of this section, and all replacements of and additions to those fixtures, except for those fixtures, replacements or additions, that under the law are "consumer goods" and that I acquire more than ten days after the date of the Note. As a general rule, fixtures are items that are physically attached to buildings, such as hot water heaters and furnaces;

(H) All of the rights and property described in Paragraphs (B) through (F) of this section that I acquire in the future;

(I) All replacements of or additions to the property described in Paragraphs (B) through (F) and Paragraph (H) of To have and to hold, all and singular the Property to the Lender, its successors and assigns forever. BORROWER'S TRANSFER TO LENDER OF RIGHTS IN THE PROPERTY I mortgage, grant and convey the Property to Lender subject to the terms of this Mortgage. This means that, by signing this Mortgage, I am giving Lender those rights that are stated in this Mortgage and also those rights that the law gives to lenders who hold mortgages on real property. I am giving Lender these rights to protect Lender from possible losses (A) Pay all the amounts that I owe Lender as stated in the Note;

that might result if I fail to:

(B) Pay, with interest, any amounts that Lender spends under this Mortgage, to protect the value of the Property and Lender's rights in the Property.

(C) Pay, with interest, any other amounts that Lender lends to me as Future Advances under Paragraph 15 below; and

(D) Keep all of my other promises and agreements under this Mortgage.

BORROWER'S RIGHT TO MORTGAGE THE PROPERTY AND BORROWER'S OBLIGATION TO DEFEND OWNERSHIP OF THE PROPERTY

I promise that (A) I lawfully own the Property; (B) I have the right to mortgage, grant and convey the Property to Lender;

and (C) there are no outstanding claims or charges against the Property, except as otherwise stated in this Mortgage.

I give a general warranty of title to Lender. This means that I will be fully responsible for any losses which Lender suffers because someone other than myself has some of the rights in the Property which I promise that I have. I promise that I will defend my ownership of the Property against any claims of such rights.

In the event I fait to defend my ownership of the Property, Lagree to reimburse the Mortgagee for any and all expenses, including attorneys fees and Court costs, incurred by the Mortgagee in defending the Property.

I promise and I agree with Lender as follows:

1. BORROWER'S PROMISE TO PAY PRINCIPAL AND INTEREST UNDER THE NOTE AND TO FULFILL OTHER **PAYMENT OBLIGATIONS**

I will promptly pay to Lender when due: principal and interest under the Note; late charges as stated in the Note; and principal and interest on Future Advances that I may receive.

2 RORROWER'S OBLIGATION TO PAY TAXES AND INSURANCE

(A) Taxes: I will pay all the taxes, assessments (public and private), sewer rents, water rates and other governmental or municipal charges, fines or impositions on the Property upon or before the date they are due. I will show Lender receipts for payment of such charges within then (10) days after Lender requests them.
