"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Walnut Lane and being known and designated as Lot No. 29 on plat of Property of Roy Styles recorded in the RMC Office for Greenville County in Plat Book Y at Page 63 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
