MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, One Thirty Five ^{Donnic S} South Main Street Associates, Ltd., a Georgia Limited Partnership (hereinafter referred to as Mortgagor) is well and truly indebted unto North Greenville College

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Sixty-Eight Thousand One hundred Twenty and No/100** -----Dollars (\$ 68,120.00) due and payable

in full on or before November 15, 1983, together

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE.

ALL that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the southeastern side of South Main Street at the intersection of East Court Street and being shown and designated on plat entitled "Property of One Thirty Five South Main Street Associates, Ltd.", prepared by Carolina Surveying Company, dated August 9, 1983, and recorded in the RMC Office for Greenville County in Plat Book 94 at Page 73, and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
