1. Payment of Principal and Interest. Horrower shall promptly pay when the principal of a strategy on the indebtedness evidenced by the Note, prepayment and late charges as provided in the Note, and the principal of and interest on any Enture Advances secured by this Mortgage

2. Funds for Taxes and Insurance.
