THIS MORTGAGE is made this 9th day of September 19 83, between the Mortgagor, WILEY E. TUCKER AND MELISSA L. TUCKER (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL BANK, FSB, a corporation organized and existing under the laws of THE UNITED STATES OF AMERICA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

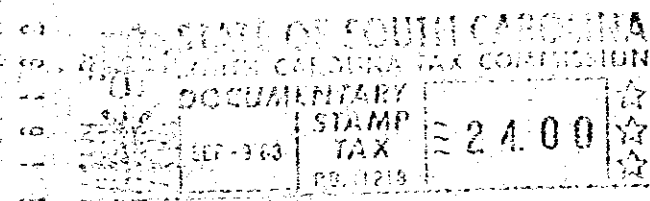
WHEREAS, Borrower is indebted to Lender in the principal sum of SIXTY THOUSAND AND NO/100 Dollars, which indebtedness is evidenced by Borrower's note dated September 9, 1983 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on October 1, 2013.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 114 on a plat of HERITAGE LAKES, recorded in the R.M.C. Office for Greenville County in Plat Book 6H at Page 19, and having, according to a more recent survey prepared by Freeland and Associates, dated June 15, 1983, entitled "Property of Wiley E. Tucker and Melissa L. Tucker", the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 113 and 114 and running thence N. 08-23-12 W. 192.61 feet to an iron pin; thence running with the line of property now or formerly of C. G. Vaughn Est. N. 88-02-41 E. 138.00 feet to an iron pin; thence running with the line of Lot 115 S. 01-58-24 E. 189.68 feet to an iron pin; thence running with Harness Trail S. 88-04-19 W. 78.84 feet to an iron pin; thence continuing with said Trail S. 84-49-39 W. 37.60 feet to an iron pin, the point of BEGINNING.

To HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
