"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Tract 15 containing 2.4 acres according to plat of Groce Meadow Estates made by Jeffery M.
