NOW, KNOW ALL MEN, THAT said Mortgagor Barton J. Edge & Dorothy L. Edge in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee, according to the condition of the said Promissory Note, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mortgagee.

FORD MOTOR CREDIT COMPANY, ITS SUCCESSORS AND ASSIGNS:

BEGINNING at an iron pin in the Southern side of a neighborhood road, and thence running along said road, S. 76-50 E. 1.70 chains to a point, corner of property of C.W. Vernon; thence along the Vernon line, S. 20-47 E. 0.00 chains to a small twin Spanish Oak; thence along the line of J. B. McAllister, N. 61-00 W. 0.00 chains to an iron pin; thence still along the line of J.B. McAllister, N. 17-15 E. 0.00 chains to the beginning corner. AND IT IS AGREED, by and between the said parties, that the said Mortgagor, his heirs, executors or administrators, shall and will forthwith insure the house and building on said lot, and keep the same insured from loss or damage by fire in at least such sums as the Mortgagee shall from time to time require and assign the policy of insurance to the said Mortgagee, its successors or assigns. And in case the Mortgagor at any time neglects or fails so to do, then the said Mortgagee, its successors or assigns, may cause the same to be insured in its own name, and reimburse itself for the premium and expenses of such insurance under the mortgage

AND IT IS AGREED, by and between the said parties in case of default in any of the payments of interest or principal as herein provided for, or in the said Promissory Note for which this instrument is evidence of security, the whole amount of the debt secured by this mortgage shall at the option of the said Mortgagee become immediately due and payable

AND IT IS FURTHER AGREED, that said Mortgagor, his heirs and assigns, shall pay promptly all taxes assessed and chargeable against said property, and in default thereof, that the holder of this mortgage may pay the same whereupon the entire debt secured by this mortgage shall immediately become due and payable, if the Mortgagee shall so elect
