To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that certain piece, parcel or lot of land with buildings and improvements thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 48 on the northern side of Havenhurst Drive of Homestead Acres as shown on plat by J. Mac Richardson, November, 1959, recorded in the R.M.C. Office in Plat Book RR at page 35, and having, according to said plat, the following metes and bounds:

BEGINNING at iron pin on the northern side of Havenhurst Drive at the joint front corner of Lot No. 47 and Lot No. 48; thence with the line of Lot No. 47, N 25 W 172.6 feet to iron pin; thence N 75-43 E. 96.6 feet to iron pin; thence with the line of Lot No. 49 S 25 E 154.6 feet to iron pin on the northern side of Havenhurst Drive; thence with Havenhurst Drive S 65 W 95 feet to the point of beginning. Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
