MODIFICATION & ASSUMPTION AGREEMENT

Eldridge, Jr., in the original amount of \$23,000.00 payable monthly at the rate of 16% interest; and secured by a first mortgage on the premises described in deed book 768 page 390, Greenville County R. M. C. Office and located on the north side of road known as Cool Creek Dr., located near Gilreath Mill, O'Neal Township, County of Greenville, State of South Carolina, and recorded in mortgage book 1580 page 855, on September 20, 1982, title to which property is now being conveyed to Cecil W. McClimon.

That the Bank of Greer has agreed to transfer of the above described property and agreed that Cecil W. McClimon may assume said mortgage on the following terms.

WHEREAS, it is now desired by the parties hereto to convert the said loan to a permanet loan with being amended so as to provide for a payment of nine (9) years, with payments at the rate of \$349.76 per month, including interest thereon at the rate of 134% per annum, to be computed and paid monthly.
