The Note contains provisions allowing for changes in the interest rate every year subject to the limits stated in the Note. If the interest rate increases, the Borrower's monthly payments will be higher. If the interest rate decreases, the Borrower's monthly payments will be lower.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

INTEREST RATE AND MONTHLY PAYMENT CHANGES

The Note provides for an initial interest rate of 10.00 Section 4 of the Note provides for changes in the Interest rate and the monthly payments, as follows: "4. INTEREST RATE AND MONTHLY PAYMENT CHANGES

(A) Change Dates The interest rate I will pay may change on the first day of May. that day every 12th month thereafter. Each date on which my interest rate could change is called a "Change Date."

Beginning with the first Change Date, my interest rate will be based on an index. The "Index" is the weekly average yield on United States Treasury securities adjusted to a constant maturity of 1 year, as made available by the Federal Reserve Board. The most recent index figure available as of the date 45 days before each Change Date is called the "Current Index."

If the Index is no longer available, the Note Holder will choose a new index which is based upon comparable information. The Note Holder will give to notice of this choice.

The first index figure for this note is 10.530. It is called the "Original Index." The Original Index plus a margin of 2.500% (after rounding the result up to the nearest 1/8 of 1%) is called the "Adjustment Base Rate."

Before each change date, the Note Holder will calculate my new interst rate by calculating the difference, If any, between the Current Index and Original Index. If the Current Index is higher than the Original Index, the Note Holder will add the difference to the Adjustment Base Rate. If the Current Index is lower than the Original Index, the Note Holder will subtract the difference from the Adjustment Base Rate. The Note Holder will then round the result of this addition to the hearest 1/3 of 1 percentage point (0,125). Subject to the limits stated in Section 4 (D) below, this rounded amount will be my new interest rate until the next change date.

The Note holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal balance of my loan Lam expected to owe on the Change Date in full on the maturity date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payments.
