Suffer (hereinafter referred to as Mortgagor) and FIRST UNION MORTGAGE CORPORATION, a North Carolina corporation (hereinafter referred to as Mortgagoe):
WITNESSETHTHAT, WHEREAS, Mortgagor is indebted to Mortgagee for money loaned for which Mortgagor has executed and delivered to Mortgagee a Note of even date herewith in the principal sum of Fourteen Thousand. One Hundred, and No/100
Dollars (\$ 14,100.00), with interest thereon, providing for monthly installments of principal and interest
beginning on the <u>lst</u> day of <u>June</u> , 19 <u>84</u> and
continuing on the <u>lst</u> day of each month thereafter until the principal and interest are fully paid;
AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the Note and this Mortgage by the conveyance of the premises hereinafter described:

NOW, THEREFORE, in consideration of the aforesaid loand and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in ______ Greenville County, South Carolina:

STATE OF SOUTH CARCLINA South Caroling Tax Commission DOCUMENTARY SO S. 6 4 121 All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the County of Greenville, State of South Carolina, on Broughton Drive, and being shown as Lot #3, Section "E", Croftstone Acres, on a plat prepared by Piedmont Engineering Service dated August 8, 1950, said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Broughton Drive at the joint front corner of Lots 2 and 3 and running thence along the common line of said lots S. 17-35 E., 151 feet to an iron pin; thence along the common line of Lots 3, 12 and 13 S. 54-41 W., 73.4 feet to an iron pin, the joint rear corner of Lots 3 and 4; thence along the line of these lots N. 17-35 W., 173.2 feet to an iron pin on the south side of Broughton Drive; thence along the south side of Broughton Drive N. 72-25 E., 70 feet to an iron pin, the beginning corner.

This being the same property conveyed to the mortgagors herein by deed of Wade H. Barber and Ann C. Barber dated May 7, 1975 and recorded in the R. M. C. Office for Greenville County on May 9, 1975 in Deed Book 1018 at Page 45.

This mortgage is second and junior in lien to that mortgage granted to First Federal Savings and Loan Association in the original amount of \$18,602.60 recorded in Mortgage Book 1338 at Page 884.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. Including but not limited to all buildings, improvments, fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or articles, whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrigeration, ventilation or other services, and also together with any screens, window shades, storm doors and windows, screen doors, awnings, stoves and water heater (all of which are declared to be a part of said real estate whether physically attached thereto or not).

TO HAVE AND TO HOLD the same with all privileges and appurtenances thereunto belonging to Mortgagee, its successors and assigns, forever, for the purposes hereinafter set out and Mortgagor covenants with Mortgagee, its successors and assigns, that Mortgagor is seized of, and has the right to convey, the premises in fee simple; that the premises are free and clear of all encumbrances except for a prior mortgage, if any; and that Mortgagor will warrant and defend title to the premises against the lawful claims of all persons whomsoever.

MORTGAGOR COVENANTS with Mortgagee, its heirs, successors and assigns as follows:

- 2. TAXES. Mortgagor will pay all taxes, assessments, water and sewer charges, and other governmental or municipal charges, fines, or impositions, for which provision has not been made hereinbefore, and will promptly deliver the official receipts thereof to the Mortgagee upon demand; and in default thereof the Mortgagee may pay the same and add the amount of such payment(s) to the principal indebtedness due Mortgagee, and the same shall be repaid by Mortgagor with interest at the then prevailing note rate upon demand.
