ASSIGNMENT OF MORTGAGES

WHEREAS, Liberty Loan Corporation, a South Carolina corporation, either directly or through its predecessor corporation (Liberty Loan Corporation and such predecessor corporations are hereinafter referred to as "Liberty Loan Corporation") was the mortgagee under certain mortgages recorded in the recording office for Greenville County (hereinafter the "Mortgages"); and

WHEREAS, the Mortgages were assigned by Liberty Loan Corporation to LLC Corporation, and in turn by LLC Corporation to Shawmut Bank of Boston, N.A., and by Liberty Loan Corporation to Shawmut Bank of Boston, N.A., by Assignments recorded in Book  $\frac{1577}{}$ , at pages  $\frac{267}{}$ ,  $\frac{307}{}$ , and  $\frac{311}{}$  (hereinafter the "Assignments"); and

WHEREAS, the Assignments were not for the purpose of transferring ownership of the Mortgages to LLC Corporation and to Shawmut Bank of Boston, N.A., but for the purpose of providing additional security for certain obligations running from Liberty Loan Corporation and LLC Corporation to Shawmut Bank of Boston, N.A., which were otherwise secured; and

WHEREAS, the obligations of Liberty Loan Corporation and LLC Corporation to Shawmut Bank of Boston, N.A. have been satisfied and the purpose of this instrument is to release any security interest which LLC Corporation and Shawmut Bank of Boston, N.A. may have had in the Mortgages.

NOW, THEREFORE, Shawmut Bank of Boston, N.A. does hereby REASSIGN TO LIBERTY LOAN CORPORATION THE MORTGAGES recorded in the Mortgage Books at the pages and on the dates with the Mortgagor set out in Schedule A attached hereto and release any security interest which it held under any Mortgage to Liberty Loan Corporation as mortgagee and does cancel, terminate and forever end the Assignments; it being the intent of this instrument to release all security interest in the Mortgages created by the above Assignments or otherwise created by Assignment to LLC Corporation and in turn to Shawmut Bank of Boston, N.A. or directly to Shawmut Bank of Boston, N.A. by Liberty Loan Corporation of any mortgages owned by Liberty Loan Corporation as mortgagee and so assigned.
