



MORTGAGE

THIS MORTGAGE is made this 20th day of August 1984 between the Mortgagor, Karen R. Moffatt and Robert A. Moffatt (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL BANK, FSB a corporation organized and existing under the laws of THE UNITED STATES OF AMERICA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").
