"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southeastern side of Edwards Road and being known and designated a Lot 2 on a plat of Hughes and Cale subdivision recorded in the RMC Office for Greenville County in Plat Book EE, at Page 128, and being more fully described as follows:

BEGINNING at an iron pin on the southeast side of Edwards Road said pin being 73.1 feet from Cahu Drive at the corner of Lot No. 1 and running thence S. 80-35 E. 149.4 feet to an iron pin; thence S. 9 E. 78.5 feet to an iron pin; thence N. 85-29 W. 200 feet to an iron pin on Edwards Road; thence with the southeastern side of Edwards Road N. 24-41 E. 95 feet to the point of beginning.
